Condo Transfer of Membership /Lease Packet Policy & Procedures

Effective 12.21.2023

Leasing Policies:

- A living unit may not be rented or leased more than twelve (12) times per year
- The minimum allowable lease period shall be thirty (30) consecutive days.
- A lease may not begin sooner than thirty (30) days after the first day of occupancy under the last previous lease.
- The lease must be written, and a fully executed copy must be provided to the Association not less than fifteen (15) days before the beginning of the lease term, together with copies of government issued photo IDs, and the completed Transfer of Membership Application Forms.
- Subleasing or assignment of the lease rights is not allowed
- Only the lessee and the lessee's spouse, if any, and their dependent, unmarried children, who live with their parents, may occupy the Living Unit during a lease.
- It is the homeowner's responsibility to provide all the Rules and Regulations to tenants and guests, as all the provisions of the Governing Documents and the Rules and Regulations of the Association will be applicable and enforceable against any person occupying a Living Unit.
- Each Living Unit is allotted 8 guest passes per year. The homeowner has the right to limit or prohibit the amount of guest passes their renter is allowed to acquire for the duration of the renter's lease

Leasing Procedures:

- The transfer fees will be charged to the homeowner's Bonita National member charging account. These fees are NON-REFUNDABLE & are subject to change.
- Transfer Fees for a Social Membership (Mandatory)
 - One month: \$100 plus 6.5% applicable tax
 - Two months: \$325 plus 6.5% applicable tax
 - Three – Five months: \$300 plus 6.5% applicable tax
 - Six months – One year: \$250 plus 6.5% applicable tax
- Transfer fee for a Golf Membership is an additional \$500 plus 6.5% applicable tax
- Transfer of Membership packets received under the required 15 days will be charged an additional \$100 expediting fee, which will be completed within 3 business days.
- Applications that are received incomplete will be returned to the homeowner for completion.
- A completed application includes (Transfer Packet Checklist):
 - The Bonita National Transfer of Membership Packet (5 pages)
 - Signed Lease Agreement between the homeowner and renter
 - Copy of the drivers' licenses or passports for all occupants
- If the rental property is a multi-family home, it is the homeowner's responsibility to reach out to the sub-association to inquire if an additional application may be required.

By my signature, I acknowledge that I have read, understand, and agree to the policies and procedures of Transferring my membership at Bonita National Golf and Country Club as defined in the Transfer of Membership/ Lease Forms packet that I have received. I understand when transferring of membership privileges, I will no longer be able to exercise those privileges during that time. It is my intent to transfer the unit's privileges to the transferee listed in this document. Members found to be in violation of the transfer of membership/lease policy will have the proper fees immediately billed to their account and will be subject to both an appearance before the Board of Directors and/or fines. Further penalties could include suspension of all club privileges for up to a year if the policy violations continue. I certify that I have provided the transferee/renter(s) the following Copies of all the Rules & Regulations, & Use Restrictions (specifically parking, commercial vehicles, pets); Key Contact Numbers for Community (Management Companies); Trash Pickup Schedule, Mailbox Key and Mailbox Information & Instructions. I understand that failure to comply with this is a violation of the Declaration of Covenants, Conditions & Restrictions for the Bonita National Community, and may result in the denial of your transfer application.

Pet Policy

General Requirements

- All pets must be registered with the administrative office using the Pet Registration form.
- Pets must be registered, licensed, and inoculated as required by law.

Type & Number of Pets Allowed

- A member, family, guest, tenant, invitee in each Living Unit may Keep not more than two (2) pets of a normal domesticated household type (cats and dogs) in the living unit.
- Birds in cages and fish in aquaria are permitted.

Prohibited Animals and/or Activities

- No reptiles, amphibians, poultry, swine, or livestock may be kept on the property.
- No pets or animals may be brought, kept, bred, or maintained on the properties for any commercial purpose – including but not limited to boarding, grooming, and breeding.
- Any aggressive breeds.

Care and Management of Pets

- Each pet owner shall be required to clean up after his or her pet.
- Pets must be leashed, or hand carried at all times.
- Pets may not be left unattended or leashed in yards, patios, or screened lanais.
- Pets shall not be permitted in any of the common areas unless under leash. Except for service animals, pets are not permitted in any Bonita National amenity (Tennis, Fitness, Spa, Pool, Clubhouse, Golf, Dining).

Restrictions, Responsibilities, and Consequences

- The board may restrict the locations where pets may be walked.
- Each member by acquiring a living unit agrees to indemnify the association and hold it harmless against any loss or liability resulting from his or her pet.
- Violations are subject to fines and suspensions, and may result in citations, pet impoundment and other penalties under the Lee County Animal Control Ordinance #14-22.
